Location

The library is currently located at 400 North Porter Street. The library owns both the land and the building at this location.

Recommendations

The Seaford District Library commission has a fire-resistant locking cabinet to safeguard the accounting records. This same cabinet should also be used to safeguard the checkbooks.

Cash money received from fines, book sales, etc. should not be allowed to accumulate and should be deposited regularly. Since the money is kept in the safe, the safe should be locked at all times.

We have previously recommended that all check signers be bonded - we reiterate this recommendation.
