We have audited the accompanying schedules of cash receipts and cash disbursements of Seaford District Library in Sussex County, Delaware for the years ended June 30, 1989 and 1988. These schedules are the responsibility of the Library's management. Our responsibility is to express an opinion on these schedules based on our audits.
